Dear Parents/Carers,

On behalf of all of us at St Mary's we hope you had an enjoyable Christmas and New Year. St Mary's has some fantastic facilities as we hope you and your children will agree. The facilities we enjoy today exist because of the generosity of current and past parents. We are asking you now if you would consider being generous and contributing to the Governors' fund for the benefit of your own children and future pupils.

What is the Governors' Fund?

Like all church state schools, which have church governors from the local community leading them, St Mary's needs financial support from our church community. This is because in exchange for this leadership, the government expects the church community to provide 10% of all the school's building and maintenance costs. As they have no assets of their own, the Governors set up their fund to collect this money. It mainly comes from the children's churches and their parents.

In recent years, the governors have supported many projects, including roof based works, the vegetable raised beds by the Infants, extensive playground equipment and the fantastic MUGA that the children really love playing on.

Helping with the cost of Education

As you know, school's finances are fully stretched at present and will be for the foreseeable future. So please consider offering financial support for the school by donating to the Governors' Fund.

Many schools request significant contributions from parents, and we request parents donate the sum of £60 per year (£5 per month) for each child. We recognise it is hard to find funds these days, but hope you agree that they will be well spent on the children in our care.

Contributions can be gift aided so that the school can claim back any income tax already paid on these contributions. Please return any completed Gift Aid Declaration forms to the school office, along with your completed donation form. Paying by standing order reduces our admin costs and so enables us to use the funds to best effect for our children. To make a donation by standing order, please also complete the Standing Order Form and send it to your local bank.


