Keeping Children Safe Online This Christmas

With Christmas just around the corner, many families will be gifting new devices to their children. From tablets and smartphones to gaming consoles and smart TVs, more devices than ever are connected to the internet. While these gadgets offer exciting opportunities for learning and play, they also come with risks if not set up properly. For some parents this will all be absolutely obvious and clear but we feel it is important to signpost to support in order to help keep children safe while online:

Before your child starts exploring their new technology, we strongly encourage you to take time to ensure the device is configured for safety. This includes:

- **Setting up parental controls** on devices, apps, and home Wi-Fi. These controls can help block inappropriate content, manage screen time, and restrict in-app purchases.
- **Creating child accounts** rather than allowing access through an adult account. Child accounts often include built-in safety features and age-appropriate settings.
- **Checking privacy settings** on social media, gaming platforms, and streaming services. Make sure profiles are set to private and location sharing is turned off.
- **Discussing online safety rules** with your child. Talk about what is appropriate to share online, how to respond to messages from strangers, and what to do if something feels wrong or upsetting.
- Explaining the importance of strong passwords and why they should never share them with friends.
- **Encouraging open communication** so your child feels comfortable coming to you if they encounter something worrying online.

Quick Checklist for Parents

- Enable parental controls on all new devices and apps
- Create a child account with age-appropriate settings
- Review privacy settings on social media and gaming platforms
- Turn off location sharing and check who can contact your child
- Set screen time limits to balance online and offline activities
- Talk about online safety rules and encourage open conversations
- Bookmark trusted resources for ongoing guidance

Top 5 Things to Check Before Your Child Goes Online

- 1. Is the device secure?
 - Ensure antivirus software is installed and the latest updates are applied.
- 2. Are parental controls active?
 - Double-check that filters, app restrictions, and purchase controls are working.
- 3. Are privacy settings correct?
 - Confirm that profiles are private, location sharing is disabled, and only trusted contacts can communicate.
- 4. Does your child know the rules?
 - Review what is safe to share, how to report concerns, and why they should never talk to strangers online.
- 5. Is screen time agreed?
 - Set clear limits and agree on times for gaming, social media, and homework to maintain balance

Attendance

Earlier this half term, we shared a letter outlining the legal position of the Department for Education and the Local Authority regarding school attendance. I would like to take this opportunity to remind you how vital regular attendance is for every child. Consistent attendance ensures that pupils benefit fully from the rich learning experiences we provide and gives them the best chance to achieve their full potential.

I am concerned about the growing number of families choosing to take holidays during term time that do not meet the criteria for exceptional circumstances. These absences lead to significant lost learning, which can have a lasting impact on progress and attainment. They also place additional pressure on teaching staff, who work hard to revisit missed content and close gaps that could disadvantage children in the future. By sharing the dates for the next academic year now, we hope this will help you plan ahead and arrange holidays during school holiday periods rather than during term time. This forward planning makes a real difference to your child's education and helps them stay on track with their learning.

As a leadership team, we are working closely with our Governors to address this issue and explore ways to support families in reducing the amount of school time lost to holidays. Your cooperation and commitment to prioritising school attendance are essential in helping us provide the best possible education for your children. Every day in school counts towards building strong foundations for success. We will be sharing more detail on how we can support great attendance at the start of the Spring Term.
